Accounts with IBBA, IJBBA & IJBBA Legacy Foundation must be in good standing in order for entries to be accepted.

PAINT WILL BE ALLOWED IN THE JUNIOR SHOW AND THE JUNIOR SHOW ONLY! NO PAINT WILL BE ALLOWED IN THE OPEN SHOW.

All animals must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves. No graphite, hair, cotton twine, etc. may be applied. Tail ties and hairnets used on the tail and switch are the only exceptions.

FACILITY RULES

In an effort to increase the safety for exhibitors and spectators alike, the IJBBA has approved the following facility rules:

- No Playing in the Arena
- No Bikes or Scooters in the Stalling Barns, Breezeways or Arena.
- No Golf Carts and/or ATV's in the Stalling Barns, Breezeways or Arena.
- No Dogs in the Arena or Breezeways. Dogs must be kept leashed or kenneled in your stalling area.
- TRASH must only go in trash receptacles: MANURE must only go in manure bins.

ARRIVAL/RELEASE OF CATTLE

Tack will be allowed in the barns at 4pm on Monday, June 24th. Cattle will be allowed to go to tieouts but cannot come into the barns. Cattle will be allowed in the barn beginning at 8:00 a.m. Tuesday, June 25th. All NJBS cattle must be in place by 3:00 p.m. Tuesday, June 25th. Open Futurity Show cattle (only) must be in place by 12:00 noon Friday, June 28th.. Cattle will be released as they complete showing and must be out of barns by midnight on Sunday, June 30th.

The IJBBA Board, Advisors & NJBS Volunteers will greet you at the Welcome Station to provide your stalling information.



STALLING INFORMATION

Each individual animal will receive 1 stall space regardless of whether said animal is entered in Bred & Owned, Owned, Futurity or any combination of shows. Pairs must purchase an additional stall for the calf at side if it is not showing by itself. Stalling requests **MUST** be included on entry forms to be recognized. No phone or email requests will be accepted. We will do our best to grant Stalling Requests where able.

ADDITIONAL STALLS

Please do **NOT** list animals on the entry form to get additional stalling space. You will have an option to add additional stall space on your entry form for \$55/Space.

BEDDING

Exhibitors will need to bring their own bedding or preorder it from the feed store. Stalls will **NOT** be prebedded this year. Please see the “feed store” section below for preorder info. You can also purchase more bedding onsite through the feed store.

TIE-OUTS

TIE-OUT SPACE WILL BE FIRST COME FIRST SERVE. Tie-outs will be next to the barns. Tie-outs are included in your entry fee. We ask that you do not take more space than what you need, if we see that you are taking extra space for cattle that are not entered then you will be asked to move. Tie-outs will be on concrete and exhibitors will need to put down bedding. You can bring your own bedding in or purchase from the feed store (onsite or preorder). **Trailers will NOT be accessible for tying out cattle. Cattle can only be tied out in the designated tie-outs area. You cannot tie to your trailer or set up tents at your trailer.** If you have panels, you are welcome to bring them for setting up tie-out pens. Additionally, panels **CANNOT** extend more than 8 feet back from the head panels to the aisle between tie-outs. Any panels/ pens that stick into the alleyway between tie-out rows will not be allowed. Panels will **NOT** be available for rent at the facility. All animals must be in the barn during the day.

FEED STORE

Bar None Country Store will be set up on site. Exhibitors can also pre-order feed, shavings, etc. by calling the Bar None Country store directly at 254-848-9112 and asking for Mike Jones OR emailing barnoneag@yahoo.com. All preorders will be delivered to your stalls before you arrive.

ENTRY INFORMATION

The online Entry Form for the National Junior Brangus Show and Brangus Futurity Shows can be found at www.juniorbrangus.com/shows. Please make sure to read carefully and provide all requested information.

IMPORTANT ENTRY DATES AND REMINDERS

- **THE NJBS & FUTURITY ENTRY DEADLINE IS: May 1, 2024**
- All registry work (registrations and transfers) must be completed before May 1st to be eligible to show! Please call the IBBA Registration Department (210.696.8231) if you have not received your paperwork prior to submitting entries or two weeks prior to May 1st.
- Absolutely no junior show refunds will be issued after May 1st.
- Absolutely no show entries or substitutions will be accepted after May 1st.
- All junior participants must be a paid active member by May 1 to participate in contests!

ENTRY FEES

- Each junior show entry requires a \$55 fee. Animals shown in both the bred & owned and the owned show require two (2) entry fees. Futurity entries are \$60 each.
- All NJBS Showmanship Contests will require an entry fee of \$10 per exhibitor. Fee must be paid during the online Entry process.

ELIGIBILITY

Exhibitors must be paid members of the International Junior Brangus Breeders Association (IJBBA), who have reached their 7th birthday, prior to January 1 of the calendar year, and have not reached their 22nd birthday, prior to January 1 of the calendar year, to be eligible to exhibit AND to participate in all NJBS contests. You must be a paid active member by June 1 to be eligible to compete in all NJBS activities! If you have not renewed this year's membership, you need to submit the \$25 fee and membership application prior to entry. Exhibitors must also have their account with IBBA/IJBBA and the IJBBA Legacy Foundation in good standing in order for their entries to be accepted.

CONTEST ONLY AND PEEWEE PARTICIPANTS

Participants DO NOT have to exhibit cattle to compete in NJBS Contests. Those participants interested in competing in CONTESTS ONLY including PeeWee Division Participants are encouraged to complete an entry form in order to receive a NJBS T-shirt and participant packet (includes tickets to any extra events and the NJBS banquet).

ENTRY INSTRUCTIONS

Complete the Entry Form and make your payment online at www.juniorbrangus.com/shows. No paper entries will be accepted.

HEALTH AND REGISTRATION PAPERS

All cattle must be accompanied by an official CVI issued within 30 days of arrival, that shows complete description of livestock as to age, sex, in addition to individual identification such as tattoo. **Fertility examination papers are required on all bulls 18 months and older. Pregnancy certification is required on all females 20 months and older.** For more information on health requirements, contact your local veterinarian. Registration papers, fertility exams, and pregnancy certificates will be viewed during cattle check-in.

DISPUTES

Any disputes that arise will be handled at the discretion of the IJBBA Board of Directors, Advisory Committee, and/or Director of Youth Activities. Their verdict in such instances will be final.

OWNERSHIP REQUIREMENTS

All entries must be in the sole ownership of the junior exhibitor no later than May 1, 2024. Entries must be the sole ownership name of one junior only with the exception of bulls. Bulls must be recorded with a minimum of 6/12ths ownership of the junior exhibitor. Juniors MUST also have possession of the bull from May 1, 2024 until show day. No heifer or cow/calf partnership entries will be accepted. Ownership will be defined as the begin ownership date in the IBBA registry system.

BRED AND OWNED OWNERSHIP REQUIREMENTS

Bred and owned animal classes shall be limited to animals both owned and bred solely by the junior exhibitor. The junior exhibitor must be the sole breeder, and first and continuous owner of the animal entered. "Breeder" is defined as the sole owner of record of the dam at the time of service based off the transfer timestamp date. "First owner" is defined as the sole owner of record of the dam at the time the calf is born. The Junior exhibitor must be the only (sole) recorded owner of the dam with IBBA (according to the IBBA registry system's timestamp) from conception to birth and the only recorded owner of the animal from birth to show day. Recorded owner is defined by the timestamp of when the transfer was completed within the IBBA registry system. A partial interest of a bred and owned bull may be sold as long as he remains in the exhibitor's care and possession throughout show career.

EXHIBITION

All OWNERS must be present at THE NJBS RING ENTRY GATE FOR THEIR ANIMAL TO BE EXHIBITED. Animals must be shown by the individual in whose name the animal is registered. The only exceptions shall be if an individual has two animals entered in the same class, or in case of A MEDICAL EVENT and approval is given by the IJBBA Executive Committee. Do not request alternate exhibitors for any extracurricular reasons. SUBSTITUTE SHOWMAN MUST BE A REGISTERED NJBS PARTICIPANT. All exhibitors agree to allow their entries to be used as demonstration animals if requested to do so by Association officials.

SHOW ATTIRE

Show harnesses will be required to be worn by each exhibitor with numbers worn in the front of the harness. Exhibitors are required to wear an NJBS shirt while exhibiting in ANY of the NJBS Shows. This includes the Owned Brangus, Ultra, and Percentage Show and all Bred & Owned Show (all shows on June 28th and June 29th). Each exhibitor will be provided ONE NJBS shirt (please designate size on entry form). Additional shirts may be purchased on the entry form. A limited number of extra T-Shirts will be available at the show.

PREMIUMS & THANK YOU NOTES

Premiums will be offered in the NJBS Bred & Owned Shows and NJBS Owned Shows. Premiums will be determined and distributed as soon as all show expenses have been paid. All junior exhibitors will be required to write four (4) thank you's to show sponsors PRIOR to receiving their entry numbers. The International Brangus Auxiliary sells packets of notecards featuring artwork from past NJBS Illustration Contest Winners. Proceeds go to the IBA Scholarship Fund. Order yours from an IBA Member today or pick them up at the show.

LIABILITY

Persons making entries in the show shall agree to abide by all the rules and regulations of the IBBA and IJBBA. All entries will be under the control and direction of the show superintendents. The International Junior Brangus Breeders Association or the International Brangus Breeders Association will not be responsible for loss, injury or damage done to, or occasioned by, or arising from, any animal or article exhibited by a junior. The exhibitor shall indemnify the above associations against all legal or other proceeding in regard thereto, as well as damage or injury to any other person or property, caused by the exhibitor of any of the animals exhibited with such exhibitor or any of the animals exhibited.

MEALS

We will have food trucks set up outside the barns for you to purchase lunch. The food trucks will be set up for a designated time and you will be able to get lunch at your own leisure. NO meal wrist bands will be sold.

NJBS BANQUET AND AWARDS PRESENTATION

The NJBS Awards Banquet will be Saturday, June 28th, at the BASE Building that is located at the Extraco Events Center. All junior exhibitors will be furnished with one banquet ticket. Family members and guests will need to purchase Banquet tickets. Tickets are \$40 each if purchased in advance on the entry form. A limited number of tickets will be available for purchase at the show for \$50 each. Numerous contest and special awards will be presented to hard working juniors, so make plans early to join us. **YOU MUST PRESENT YOUR TICKET AT THE DOOR! NO EXCEPTIONS. SAVE MONEY & pre-order Banquet Tickets for your family & guests!** Only a limited number will be available at the show and once tickets are gone, no extras will be available - **NO EXCEPTIONS!**

FITTING

PAINT WILL BE ALLOWED IN THE JUNIOR SHOW AND THE JUNIOR SHOW ONLY! NO PAINT WILL BE ALLOWED IN THE OPEN SHOW. All animals must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves. No graphite, hair, cotton twine, etc. may be applied. Tail ties and hairnets used on the tail and switch are the only exceptions.

CATTLE CHECK - IN

The original registration certificate must be presented during cattle check-in. If the animal's registration papers have been stamped by IBBA staff then the animal does not physically have to come up for check-in. Fertility exams and pregnancy certificates will be checked at check-in. Illegal coloring, scurs, tattoos, etc. will all be checked during check-in. Prior to check-in, heads of exhibited animals must be clipped of all hair, including topknots. Animals not in compliance at check in will be required to comply before check in is complete, or they will not be allowed to show.

DNA PARENT VERIFICATION

All animals born on or after 1/1/21 are required to have completed parent, both sire and dam, verification on file at IBBA prior to the show check-in for them to be eligible to show in the junior show. If an animal does not have DNA parent verification completed at that time, they will be ineligible to show.

- a. If the calf at side is over 90 days of age by the date of show check-in, it must have parent verification completed by show check-in. If it is under 90 days, parent verification of the calf is not required.

PLEASE SEE PERCENTAGE FEMALE AND STEER SHOW RULES FOR THEIR DNA PARENT VERIFICATION SPECIFIC RULES.

The NJBS Owned Ultra Bull Show will not have divisions. Champion and Reserve Champion will be selected from the class winners.

CLASS BREAKS FOR JUNIOR AND SENIOR HEIFER AND BULL CALVES

Born September 1 and AFTER (All Show as 1 division) “Calf Division”

All Cattle born September 1st and after will be weighed and classed according to weight. Official weights will be taken the day prior to the show, by the Show Committee.

There will be three different weigh periods, the day before the B&O show, the owned show, and the Futurity Show. Animals will weigh according to when their first show is. For example, if an animal is showing the B&O or Percentage show then they will weigh the afternoon before that show and do not have to weigh again, but Futurity only cattle will weigh the day before the Futurity show. Cattle cannot weigh early.

Breaking Classes:

- Cattle will be shown as one division and labeled as the “Calf Division”
- The first class will be cattle less than 400 lbs
- There will be no more than a 100 lb variance within a class (with the exception of class 1)
- Maximum of 10 hd per class
- A group of 3 show committee members will break the classes
- The WDA along with DOB will be written on weight cards and displayed on back of show harness. Scrotal Circumference will also be provided on bulls.

****It's the exhibitor's responsibility to get cattle on the scale at posted weigh in time.**

PERCENTAGE FEMALE SHOW

THE NJBS PERCENTAGE HEIFER SHOW WILL BE OPEN TO:

- A. Brangus Premium Gold/ Brangus Built - Progeny of Registered Brangus, Red Brangus, or Ultra and any commercial animal. Must maintain a minimum of 50% registered Brangus/Red Brangus/Ultra genetics.
- B. Brangus Optimizer - Progeny resulting from mating Registered Brangus or Red Brangus and a registered animal from another beef breed recognized by the U.S. Beef Breeds Council, other than Angus or Red Angus. Must maintain a minimum of 50% registered Brangus genetics.
- C. Appendix Registered Brangus - Any registered Brangus which otherwise would be illegal to show in the registered shows, such as, any animal found to have scurs and/or slick spots, animals with illegal white (white in front of the naval) or any indication of brindling (a color pattern characterized by red streaks mingled with black), or red animals with any unacceptable coloring (according to the IBBA Red Hide Color Scale and including Brown, Grey, Yellow, Light to White, White Legs or Black Muzzle).
- D. UB Pending - Ultra's with less than 50% Brangus heritage. Parents must be enrolled or registered within IBBA's registry.

SPECIAL RULES FOR THE NJBS PERCENTAGE HEIFER SHOW

1. Owner of record on all percentage heifers entered in the Percentage Show must be active members of the IJBBA in good standing.
2. All animals must be registered with the IBBA and original registration papers must in the name of the junior exhibitor. The registration certificate (or photocopy) for each entry must be available for presentation to the Superintendent or show manager at the time entries are verified prior to judging.
3. The registration number, permanent animal identification number (brand or tattoo), birth date and at least one registered Brangus parent must be listed on the entry form.
4. All percentage heifers showing at the NJBS must be polled or dehorned /free of horns. Slick spots are permitted.
5. Prior to check in, heads of the animals must be clipped of all hair, including top knots, and be free of scurs/ horns.
6. No percentage heifer may be shown that has been artificially filled with any amount of liquid at any time once the animal enters the grounds of a show. The individual involved with an animal being artificially filled will be banned from the show ring for one year and the animal will be disqualified from exhibition at that particular show. The official show veterinarian may administer liquids orally, if so needed without disqualifying animal(s) from exhibition.
7. All animals must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves. No graphite, hair, cotton twine, etc. may be applied. Tail ties and hairnets used on the tail and switch are the only exceptions..
8. All percentage heifers 20 months of age or older exhibited, must have available at the time of check-in, a certificate of pregnancy issued by an accredited non-owner veterinarian, or blood test results certificate. If the female is open due to being in an embryo transfer program, a certified copy of the flush record showing viable embryos produced by the said female must be presented at check-in, by a non-owner embryologist. If verification cannot be produced, the female will be allowed to participate if the exhibitor can produce a qualified veterinarian to examine the female at the show site and verify pregnancy.
9. Percentage heifers showing must adhere to the classifications.
10. Percentage heifers showing with a calf at side, are required to have an IBBA registered percentage natural calf, not older than 250 days of age on show date. All calves exhibited at the side of a female must be recorded with the IBBA and meet all rules required for show.
11. DNA parent verification is required on the Brangus side of the pedigree prior to check-in.

STEER SHOW

THE NJBS STEER SHOW WILL BE OPEN TO:

Brangus, Red Brangus, Ultrablack, Ultrared, or any Percentage steer. Percentage animals must be at least 50% Brangus, Red Brangus, or Ultra Genetics.

ALL STEERS must be DNA Parent Verified by the time of check in to prove they are at least 50% Registered Brangus, Red Brangus, or Ultra Genetics.

GUIDELINES FOR THE NJBS STEER SHOW

- Steers must weigh in at the assigned time for steer weigh in on the NJBS Schedule.
- Steers will be split into two divisions - prospect and progress.
Steers less than 900 pounds will show in the prospect division and steers weighing over 900 pounds will show in the progress division.
- Class winners in the prospect division will be selected for Champion and Reserve Champion Prospect Steer.
- Class winners in the Progress division will be selected for Champion and Reserve Champion Progress Steer.

NEW

SPECIAL RULES FOR THE NJBS STEER SHOW

1. Owner of record on all steers entered in the Steer Show must be active members of the IJBBA in good standing.
2. All animals must be registered with the IBBA and original registration papers must be in the name of the junior exhibitor. The registration certificate (or photocopy) for each entry must be available for presentation to the Superintendent or show manager at the time entries are verified prior to judging.
3. The registration number, permanent animal identification number (brand or tattoo), birth date and at least one registered Brangus, Red Brangus, or Ultra parent must be listed on the entry form.
4. All steers showing at the NJBS must be polled or dehorned/free of horns. Slick spots are permitted.
5. Prior to check in, heads of the animals must be clipped of all hair, including top knots.
6. No steer may be shown that has been artificially filled with any amount of liquid at any time once the animal enters the grounds of a show. The individual involved with an animal being artificially filled will be banned from the show ring for one year and the animal will be disqualified from exhibition at that particular show. The official show veterinarian may administer liquids orally, if so needed without disqualifying animal(s) from exhibition.
7. All animals must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves. No graphite, hair, cotton twine, etc. may be applied. Tail ties and hairnets used on the tail and switch are the only exceptions.
10. **DNA parent verification is required on the Brangus side of the pedigree prior to check-in.**

PHENOTYPE AND GENOTYPE SHOW

The Phenotype and Genotype Show was created for juniors to show their heifers in an additional competition while providing an educational opportunity to learn about the value of Expected Progeny Differences (EPDs) as a part of the process in selecting seedstock.

Animals entered in the PGS will be evaluated under a system that requires both genotypes and phenotypes to be considered. The results will be a composite score where the genotype (EPDs) placing and phenotype placings will be used, the weighted final placing will be comprised of 60% Genotype placing and 40% Phenotype Placing.

Rules:

1. Classes and divisions will follow the owned female shows class breaks. Brangus, Red Brangus, and Ultra black/Ultrareds will have their own Phenotype and Genotype show.
2. The Genotype placings will result from the rankings of the GE-EPDs. The GE-EPDs will be sent to the approved EPD judge and they will rank the animals strictly off of the GE-EPDs.
3. The Genotype judge will receive entry number, birthdate, and EPDs/\$Values (CED, BW, WW, YW, Milk, TM, CEM, SC, REA, IMF, FAT, STAY) along with a percentile ranking.
4. The phenotype results will be equivalent to how the animals are ranked in the owned show in each respected division; Brangus, Red Brangus, Ultrablack/Ultrared.
5. Heifers entered in the PGS show WILL NOT be required to enter the show ring an additional time, the phenotype placing portion for the PGS show will come directly from the owned show placings.
6. The final placing for the Phenotype and Genotype show will be comprised of a weighted average from the Genotype show and Phenotype show. Final placings are 60% genotype results and 40% phenotype results.
7. Entries in Cow/Calf Pair classes are excluded from the PGS show. Entries in the Senior Heifer divisions that may have calves at side are eligible, provided they meet the GE EPD requirements.
8. All Animals born January 1, 2021 and after must be DNA parent verified.
9. In the event of a tie, the Genotype placing will be the tie breaker.

To enter:

1. All animals entered in the owned female show with GE-EPDs on file with IBBA at the entry deadline will automatically be entered in the Phenotype and Genotype show with no additional entry fee.
2. Basic parentage testing does NOT qualify for this show.
3. GE-EPDs are required at the time of the entry deadline to be entered into the PGS Show.
4. Any animal with interim EPDs or EPDs not enhanced with genomic results at entry deadline will NOT be allowed to show.

CONTEST INFORMATION AND RULES

ELIGIBILITY

To be eligible to participate in NJBS contests, you must be a paid IJBBA member by June 1, 2024. The minimum age to participate in the show and/or most contest activities is 7, as of January 1. Some Contests recognize PeeWee and Adult divisions – please refer to specific contest rules for further information.

DIVISIONS

For contest purposes, the following divisions will be recognized. Contest ages are as of January 1, 2024.

CONTEST REQUIREMENT

CONTEST CHECK-IN

Contest Check-In will be held online in June. Once all Entry Forms are received, exhibitors will receive an email with a link to complete the NJBS Contest Check-In Form and submit their contest entries. Exhibitors will need to upload electronic versions of their contest entries (photos, ads, etc.) through the Form. Those interested in competing in contests must sign up for each individual contest by the deadline provided in the email. If you are attending NJBS to participate in CONTESTS ONLY, please fill out an Entry Form indicating such so we can ensure that you receive a NJBS T-shirt and participant packet! The only contest that requires an entry fee is showmanship (\$10). That entry fee will need to be submitted with your NJBS Entry Form.

TEAMS

Contests require teams in order to participate. Exhibitors will select their own teams and be responsible for finding a full team. If you need help you can contact an IJBBA director but we cannot guarantee you a team. Awards will be given for Grand and Reserve Grand Teams (1st & 2nd Place) for each team contest.

HIGHPOINT INDIVIDUAL AWARDS

To encourage more participation in all NJBS Contests, the IJBBA is offering a \$250 cash prize to each HighPoint Individual. HighPoint Individuals are calculated by points awarded for ranking in all eligible activities. Awards will be presented to the HighPoint Individual in each of the following divisions: Novice (Age 7-10), Junior (Age 11-13), Intermediate (Age 14-16), Senior (Age 17-21). Points are awarded based on rank for individual contests. No participation points will be awarded. Points will be awarded to first through tenth place. - Novice and Junior division contestants will be permitted to use a maximum of five (5) 3x5 inch note cards. All writing must be on only one side of each card.
- Contestants submit their note cards to their speech monitor prior to speaking for review. Notecards will be evaluated for adherence to these rules and then returned as the contestant is called up to present their speech.
- Speech rooms will be closed to the timer, judges, contestants and sponsor. The speech timer can record speeches but contestants must provide a phone/device to the timer when they enter the room.

INTERMEDIATE DIVISION (AGES 14-16):

Content: The topic for the intermediate division can be any aspect concerning Brangus cattle or the beef industry.

Rules:

If entries do not meet the following requirements, they will be disqualified.

- All speeches must pertain to the described topic.
- The speech cannot have been presented for competition at a previous NJBS.
- No minimum time limit is applied to intermediates but there is a maximum limit of six minutes.
- Intermediate division contestants will be permitted to use a maximum of three (3) 3x5 inch note cards. All writing must be on only one side of each card.
- Contestants submit their note cards to their speech monitor prior to speaking for review. Notecards will be evaluated for adherence to these rules and then returned as the contestant is called up to present their speech.
- Speech rooms will be closed to the timer, judges, contestants and sponsor. The speech timer can record speeches but contestants must provide a phone/device to the timer when they enter the room.

ROGER AND JANET GREUEL SPEECH CONTEST (CONT.)

SENIOR DIVISION (AGES 17-21):

Content: The senior public speaking contest is an impromptu speech format where contestants will be given a current beef industry topic and then be given information for that topic to research and write their speech.

Rules:

If entries do not meet the following requirements, they will be disqualified.

- All speeches must pertain to the given topic.
- Contestants must arrive at the time posted for their allotted preparation time.
- Participants will be given 30 minutes for preparation of their speech. At the end of that time, they will be ushered to the judging room and deliver their speech.
- Senior division contestants will be furnished with and permitted to use a maximum of three (3) 3x5 inch note cards. All writing must be on only one side of each card.
- The minimum time requirement for the senior level will be two (2) minutes with a maximum of six (6) minutes.
- Speech rooms will be closed to the timer, judges, contestants and sponsor. The speech timer can record speeches but contestants must provide a phone/device to the timer when they enter the room.

Evaluation Criteria: Each judge will be allowed to ask questions after a speech is given and contestants may be scored on their ability to answer questions. After each contestant has made his/her presentation, they will be scored on composition and delivery. Specific judging criteria includes: their ability to gain the audiences' attention and interest, the organization and execution of their talking points, their ability to speak clearly and clearly convey their topic. Excessive reference to notes may result in deductions from his/her score. No visual aids of any kind will be allowed, just the junior and their note cards. A time keeper will record the time used by each contestant in delivering speech, noting under time and overtime, if any, for which deductions will be made.

TEAM FITTING CONTEST

HighPoint Calculation: No points will be awarded towards HighPoint for this contest.

Teams: There will be two divisions - Novice/Junior division and the Int./Senior Division. Contestants will select their own teams and will consist of three (3) team members. Oldest team member determines the division. Contestants cannot move down divisions but can only move up. For example, a senior cannot compete on a novice/junior team but a novice/junior can compete on an Int./Senior team. **Contestants can only compete on one team.**

Rules:

If entries do not meet the following requirements, they will be disqualified.

- The team members will be allowed 30 minutes to fit the entire animal.
- At the end of the 30-minute period, teams will be given one minute with cattle still in the fitting chutes to put all supplies in buckets and clean up fitting area..
- No additional fitting, by anyone, will be allowed after the timed period is over.
- Paint is allowed in the team fitting contest. No graphite, hair, cotton twine, etc. may be applied.
- Teams are responsible for chutes, blowers, and all other fitting supplies. Teams are responsible for securing their own power. Generators are encouraged.
- A team-designated member presents the animal for final judging and must wear harness and team number.
- The show halter can be on the animal before the start of the contest.
- Teams are allowed to have a junior member scratch the animal. The junior member scratching the animal is not apart of the team and is to offer no coaching.

Evaluation Criteria: Judges will be evaluating the teams for organization, instruction, teamwork, and their ability to fit the animal. The score breakdown is 50% teamwork/organization and 50% fitting.

JUDGING CONTEST

HighPoint Calculation: Points based on rank are awarded. Points will be awarded 1st through 10th in each division. For example, 1st place will be awarded 100 points, 2nd place awarded 90 points, 3rd place will be awarded 80 points, etc.

Divisions: Novice (Age 7-10), Junior (Age 11-13), Intermediate (Age 14-16), Senior (Age 17-21) & Adult (age 22+).

Rules:

If entries do not meet the following requirements, they will be disqualified.

- This contest will be on an individual basis only - NO TEAMS.
- Contestants should bring their own writing utensil and clipboard (if desired).
- Classes will be timed (8 minutes per class)
- Absolutely no talking, looking at cell phones or other material, or horse-playing will be allowed! One warning will be given by the monitor and any further violation will result in that contestant being excused from the contest and/or his/her cards not being scored.
- Some classes may use scenarios while others will serve as questions classes.

Evaluation Criteria: Standard judging cards/scoresheets will be provided and scored electronically.

SKILL-A-THON CONTEST

HighPoint Calculation: Points based on rank are awarded. Points will be awarded 1st through 10th in each division. For example, 1st place will be awarded 100 points, 2nd place awarded 90 points, 3rd place will be awarded 80 points, etc.

Divisions: PeeWee (Age 3-6), Novice (Age 7-10), Junior (Age 11-13), Intermediate (Age 14-16), Senior (Age 17-21) & Adult (age 22+).

Description: The Skill-A-Thon contest is a written contest in which IJBBA members between 7 and 21 as well as adults and pee-wees may participate. Questions will range from general Brangus to general agriculture information. Contestants will go from station to station answering the questions on their answer form. There will be different question sets for each of the age divisions. These question sets will vary in knowledge level and skills proficiency depending upon the age division and all age divisions will be ran simultaneously.

Rules:

If entries do not meet the following requirements, they will be disqualified and scoresheets will not be graded.

- No talking between participants is allowed in the Skill-A-Thon area.
- Participants may quietly ask their table monitors questions on clarification of instructions only.
- Participants will be given a time limit at each station. Time will be announced by the moderator.
- When the moderator calls time, participants must move to the next station. No one can advance before time is called.
- PeeWee and Junior Divisions will be taken through their stations with personal monitors who will read the questions and help mark their scoresheets for them. They may ask table monitors to read questions or parts of questions for them.
- All equipment and materials must remain at the station. You may NOT handle materials and equipment.
- Scoresheets must be clearly marked and writing must be legible.

Evaluation Criteria: Scoresheets will be electronically graded with TieBreaker questions tallied only in the event of a tie.

Description: Brangus Jeopardy will consist of 2 rounds. The first round will be a preliminary round which will be the skill-a-thon contest. Contestants pre-lim score will be their skill-a-thon score. The 8 teams with the highest scores will move on to the final jeopardy round. The final round of jeopardy games will follow a JEOPARDY style format with contestants answering questions pertaining to Brangus, Red Brangus, and all facets of the agriculture industry. There will be a mix of free-for-all questions, one-on-one questions and “Double Jeopardy” with wagered team questions.

Rules:

If entries do not meet the following requirements, they will be disqualified.

HighPoint Calculation: Points based on rank are awarded. Points will be awarded 1st through 10th in each division. For example, 1st place will be awarded 100 points, 2nd place awarded 90 points, 3rd place will be awarded 80 points, etc.

Divisions: Five divisions: PeeWee (ages 3-6), Novice (ages 7-10), Junior (ages 11-13), Intermediate (ages 14-16) and Senior (ages 17-21).

Rules:

If entries do not meet the following requirements, they will be disqualified.

- Participants will be allowed to exhibit heifers or steers for the Showmanship Competition – No bulls will be allowed in the showmanship contest.
- Cow/calf pairs will NOT be eligible to participate unless the individual showing the calf is eligible in that age group and is competing as a separate entry. If a lactating cow is shown, the calf must not be inside the perimeter of the show ring unless there is an eligible exhibitor showing the calf as a separate entry.

- Each contestant must be a paid IJBBA member and is responsible for securing the animal to show.
- Competition will NOT require fitting.
- Two divisions will run in each ring with only one judge.
- There will be a \$10 entry fee for the NJBS Showmanship Contest. This fee must be paid with your online Entries.
- Contestants do not have to use the same animal in their heat and the finals.

Division Specific Rules and Information:

PeeWee Division: Contest will be held **AFTER** the regular Showmanship Contests. PeeWee Showmen are encouraged to complete an NJBS Entry form and include their showmanship entry fee. Completion of the form is encouraged so we can ensure that you receive a NJBS T-shirt and participant packet. IBBA OPEN SHOW RULES

Mission Statement

The IBBA seeks to provide and support livestock shows and exhibitions that promote all recognized and registered Brangus, Red Brangus and Ultra cattle (collectively Brangus) of our association. The objective of our shows is to provide a fair and collaborative forum where IBBA members may display their cattle, market their Brangus ranches and practice ethical Herdsmanship.

The following rules and guidelines apply to all IBBA sanctioned and sponsored shows. All IBBA and IJBBA members will abide by the show rules as adopted and posted online at gobrangus.com, regardless of any show premium book. In addition, any show, fair, event, or display in which Brangus, Red Brangus, UltraBlack, or UltraRed cattle participate should follow these rules as adopted by IBBA. All entries are subject to the provision of a rule established by the IBBA.

Eligibility

1. The owner(s) of record on all animals entered in an IBBA National or Regional point show must be an active member(s) of the IBBA in good standing.
2. Animals must be registered Brangus, Red Brangus, UltraBlack, or UltraRed with the International Brangus Breeders Association (IBBA) to be eligible to compete in an IBBA-sponsored show. Animals recorded in the IBBA Appendix registry are ineligible to show.
3. UltraBlacks and UltraReds must show separately from Brangus and Red Brangus, with the exception of calves shown at the side of their dams in both the Female and Cow Calf show. The registration prefix of the dam determines the classification of the pair.
4. All calves exhibited at the side of the female must be registered with the IBBA and meet all rules required for show eligibility and inspections of exhibits (refer to Rule 9.a.). The registration prefix of the dam determines the classification of the pair.
5. Animals eligible to be shown in group classes must be entered and shown in respective individual classes. Cows exhibited in the cow/calf classes are not eligible for the group classes.

Animal Identification

6. The registration certificate (or photocopy) for each entry must be available for presentation to the Superintendent or show manager at the time entries are verified prior to judging. Digital images and herd book data sheets will not be accepted.
7. Once an animal's identification has been verified by visual inspection of a brand or ear tattoo, its registration papers will be stamped with seal of the IBBA with the date of the inspection. In future shows, this registration certificate with the seal will need to be presented at check in for identification purposes only. If this registration certificate is presented with the seal of the IBBA, the additional inspection of a brand or ear tattoo is not required. If a new or unstamped certificate is presented, the animal's identification must be verified again before a stamped is received again.
Any animal is subject to recheck by the IBBA Ethics Committee at any show at any time.
8. Any animal upon check in which does not have a legible tattoo or brand corresponding to its registration certificate is ineligible to show. An animal may be tattooed immediately at a show for reinspection.

Parent Verification

9. All animals are required to have completed parent, both sire and dam, verification on file at IBBA prior to the show check-in. If an animal does not have DNA parent verification completed at that time, they will be ineligible to show. DNA parent verification is defined as having submitted DNA samples per the IBBA DNA testing process of the animals being entered, their sire and their dam, and then having the show animal's genotype match to that of both parents as determined by the IBBA.

- a. If the calf at side is over 90 days of age by the date of show check-in, it must have parent verification completed by show check-in. If it is under 90 days, parent verification of the calf is not required.
- b. Cows in the cow/calf pair classes are exempt from the parent verification requirement if they are born prior to September 1, 2016.

10. IBBA reserves the right to collect DNA samples at any IBBA-sanctioned show. Collection will be conducted by random draw for retesting of parentage at the association's expense. At the six national IBBA-sanctioned shows, three random samples will be collected from Brangus and UltraBlack entries and three random samples will be collected from Red Brangus and UltraRed entries. An animal found to not match the stated pedigree must resolve the question before it is allowed to show again. I

Physical Inspection and Eligibility

11. Prior to check-in, heads of exhibited animals must be clipped of all hair, including topknots and be free of scurs and/or slick spots. Animals not in compliance at check in will be required to comply before check in is complete, or they will not be allowed to show.

12. Any animal found to have scurs and/or slick spots; or evidence of incisions, surgical or otherwise, in the following areas: head, testicles, sheath, navel, or dewlap; including scars from caesarean sections, will be disqualified from showing. They shall be disqualified at the show where the violation is determined and all future IBBA sponsored and sanctioned shows. A veterinary statement of purpose or cause will not be accepted.

13. Animals with illegal white (defined as white in front of the navel) or any indication of brindling (a color pattern characterized by red streaks mingled with black), or red animals with any unacceptable coloring (according to the IBBA Red High Color Scale – available at gobrangus.com – and including Brown, Grey, Yellow, Light to White, White Legs or Black Muzzle) are ineligible for show at the show in which the color issue is found. The animal is eligible for inspection at future shows.

14. No animal may be shown that has been pumped with any amount of liquid at any time once the animal enters the grounds of a show. The official show veterinarian may administer liquids orally, if so needed, without disqualifying animal(s) from exhibition.

- a. A protest of this violation must be submitted per the Violation Policy
- b. Penalty: The fitter and ranch entity involved with an animal being artificially filled will be banned from the show ring for one year and the animal will be disqualified from exhibition at that particular show.

15. All entries may be classified for judging on an age basis and should be entered in class according to age. All cattle 18 months (550 days) of age and younger are subject to dental inspection by random check or official protest. Protests can be made at any IBBA show or facilitated by a ranch visit by IBBA Field service representatives. Upon inspection by the ethics committee or IBBA field service representative, photographs of teeth will be taken along with the animal private herd number (tattoo or brand). The photographs will be submitted to a panel of 3 qualified independent specialists that are USDA certified and an accredited veterinarian for final decision. Animals will not be deemed ineligible until the official decisions from the 3 qualified independent specialists is returned to the IBBA. Cattle 18 months (550 days) of age and younger that are inspected and found to have the eruption of ADULT incisors will be subject to disqualification from any IBBA sponsored show. Points accumulated for the present show year by the falsely aged animal will be removed from the SHOW ANIMAL STANDINGS LIST, and that animal will be ineligible for awards.

Fitting and Presentation

16. Animals unethically fitted to alter the conformation or appearance of the animal, as determined by the appointed IBBA Ethics Committee or IBBA Staff, will be immediately disqualified at the show in which the violation occurred. This includes:

- a. No animal may be shown that has had any foreign objects, glued to or otherwise attached in a manner so as to alter its conformation or change its appearance.
- b. Paint or coloring agents of any kind are not to be used on any animal exhibited at IBBA sponsored shows.

17. All bulls must have a nose ring or nose restraint with the lead attached at all times, with the exception of being tied in the stalls and tie outs. This includes but is not limited to being in the show ring and during check in. The nose lead/nose restraint must be an additional lead and not part of the halter. For example, running the lead of the halter through the nose ring as the restraint is not within guidelines. Bulls 250 days and younger are exempt from this requirement.

18. Unruly animals that cannot be kept under control will be disqualified at the said show. If an animal breaks away from its handlers three times, they will be dismissed from the show ring and not eligible to show at that particular show.

Fertility and Performance Requirements

19. Weights and scrotal measurements will be taken on all bulls at check-in at all six of the IBBA National Shows.

20. All Brangus bulls 18 months of age or older that are exhibited at IBBA sponsored shows must have passed a fertility examination given by a non-owner licensed veterinarian or a non-owner certified technician to the standards of the Society of Theriology to be eligible to show. The results of the examination must be available at check-in. Once a bull has a positive examination, retesting is not required.

21. All females 20 months of age or older exhibited at IBBA sanctioned shows, must have available at the time of check-in, a certificate of pregnancy issued by an accredited non-owner veterinarian, non-owner certified professional or blood test results certificate. If a blood tests results certificate is provided, it must be blood collected by a non-owner veterinarian or non-owner certified professional, and documented. Females showing in the Senior Heifer Division of Spring Shows (January 1 through May 31) must adhere to the classifications and have an IBBA registered natural calf, not older than 250 days of age on show date.

Show Rules Violation Policy and Penalties

23. The IBBA and its representative have the authority to request and require such tests as they deem necessary to verify the accuracy of the classification, pedigree of exhibited animals and enforce all show rules as adopted by the IBBA. IBBA representatives shall include the appointed Ethics Committee at each show. A decision by the Ethics Committee and/or the IBBA representative shall stand at the show in which it is made.

24. Owners are responsible for any infraction committed by a non-member or anyone employed or contracted by the owner.

25. A valid show rules violation complaint must be accompanied by a written statement describing the violation, the perpetrator of the violation, and signed by an active member of the IBBA. This written complaint will be presented to an Ethics Committee consisting of the Chairman of the Show Committee and the three person Ethics Committee that has been previously appointed for the show where the complaint is presented. All four people will be current members of the Show Committee.

26. The Ethics Committee shall rule on the validity of the rule violation. The Ethics Committee shall visit with the perpetrator, present the written complaint, and make a ruling on the complaint if valid. The penalty will be applied according to each stated rule above.

27. The perpetrator is entitled to appeal any decision made by an IBBA representative, Ethics Committee, a veterinarian, certified industry professional or designated association representatives to the IBBA Board of Directors. The following requirements must be met: 1) the appeal is in writing and is signed by the appealing party; and 2) the appealing party files the written appeal with the IBBA Board of Directors as soon as possible after the decision is rendered however, the ruling will stand at the show in which the violation occurred. If the IBBA Board of Directors over turns the ruling of the Show Committee Ethics Committee, the exhibitor and or animal in question will be allowed to return to future shows. The IBBA Board of Directors has the right to disqualify the perpetrator from the IBBA approved show after hearing an appeal. The IBBA's Board of Directors decision is final.

28. Entries that have not complied with all of the above rules will not be eligible to show, to receive premium monies, or earn points in the IBBA's Show Sire of the Year, Show Dam of the Year, Show Bull of the Year, Show Heifer of the Year and Show Cow Calf Pair awards.

29. For and in consideration of the opportunity to participate in any function each exhibitor hereby releases the Association, its officers, directors and representatives from negligence, any and all claims, suits, and judgments past, present, or future, arising from or connected with the administration or use of such test or examination and the resulting decision there from.

Presentation of Classes for International Brangus & Red Brangus Shows

An IBBA National Point show shall be conducted in the order described below. Regional and non-Point Show may choose to conduct a show in a difference manner.

IBBA National Point Show class order:

- I. The Brangus Show will begin with the Black Female classes. Junior Heifer Calf classes will be judged through Junior Heifer Calf Champion and Reserve Junior Heifer Calf Champion.
- II. Then, the Red Female classes will enter the ring and will be judged through Junior Heifer Calf Champion and Reserve Junior Heifer Calf Champion.
- III. This procedure will be alternated between Black and Red Shows until all age champions have been selected.
- IV. After this, the Black Female Age Division Champions (Junior Heifer Calf Champion, Senior Heifer Calf Champion, Summer Champion Heifer, Yearling Champion Heifer and Senior Champion Heifer) will be brought back to the ring for the Black Female Grand Drive. The judge will select the Grand Champion Black Female and Reserve Grand Champion Black Female.
- V. Upon completion of the Black Grand Drive, the Red Female Age Champions will be brought back to the ring for the Red Female Grand Drive.
- VI. The Cow/Calf classes will begin with the Black females. The Black Cow/Calves will be judged through Champion and Reserve
- VII. Champion Cow/Calf. Then, the Red Cow/Calf classes will be judged through Champion and Reserve Champion Red Cow/Calf.
- VIII. The above procedure will be followed in the bull judging, beginning with the Black classes and alternating between Red and Black Shows. If a division does not have any cattle entered, the division will be skipped.
- IX. Group classes will be judged with Black Group Classes all being exhibited first, followed by all Red Group Classes.

NEW CLASS BREAKS FOR JUNIOR AND SENIOR HEIFER AND BULL CALVES

Born September 1 and AFTER (All Show as 1 division) “Calf Division”

All Cattle born September 1st and after will be weighed and classed according to weight. Official weights will be taken the day prior to the show, by the Show Committee.

There will be three different weigh periods, the day before the B&O show, the owned show, and the Futurity Show. Animals will weigh according to when their first show is. For example, if an animal is showing the B&O or Percentage show then they will weigh the afternoon before that show and do not have to weigh again, but Futurity only cattle will weigh the day before the Futurity show. Cattle cannot weigh early.

Breaking Classes:

- Cattle will be shown as one division and labeled as the “Calf Division”
- The first class will be cattle less than 400 lbs
- There will be no more than a 100 lb variance within a class (with the exception of class 1)
- Maximum of 10 hd per class
- A group of 3 show committee members will break the classes
- The WDA along with DOB will be written on weight cards and displayed on back of show harness. Scrotal Circumference will also be provided on bulls.

****It's the exhibitor's responsibility to get cattle on the scale at posted weigh in time.**
